1. The **Kingdom of Cambodia** has received loans from the Asian Development Bank (ADB), Agence Francaise de Development and a grant from Government of Australia towards the cost of **Rural Road Improvement II, Additional Financing**. Part of these loans and a grant will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB. The eligibility rules and procedures of ADB will govern the bidding process.
2. The **Ministry of Rural Development (MRD)** of the Kingdom of Cambodia (“the Employer”) invites sealed bids from eligible Bidders for construction of above mentioned Package CW3B by double bituminous surface Treatment (DBST), with contract period of nine hundred ten (910) days.
3. **International Competitive Bidding (ICB)** will be conducted in accordance with the ADB’s [Single Stage – One Envelope](#) procedure and is open to all eligible Bidders as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - Bidder should have participation in at least one (1) contract that has been successfully or substantially completed within the last seven (7) years and that is similar to the proposed works, where the value of the Bidder’s participation exceeds US\$ 8.00 million. Similar works shall be any roads or highway works.
 - The Bidder should have an average annual construction turnover of US\$ 8.00 million, calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.
5. To obtain further information and inspect the Bidding Documents, Bidders should contact the address mentioned below during office hours from 8:00 – 11: 30 hours in the morning and 14:30 – 17:00 hours in the afternoon.
6. To purchase the Bidding Documents in English, eligible Bidders should:
 - Write to the address mentioned below requesting the Bidding Document for Package CW3B;
 - Pay a non-refundable fee of US\$ 350 (US Dollars Three Hundred Fifty only). The method of payment is direct deposit of cash to account.

Electronic Bid submission is not permitted. Late Bids will be rejected.

8. When comparing Bids, ADB's Domestic Preference Scheme will not be applied in accordance with the provision stipulated in the Bidding Document
