1. The Royal Government of Cambodia (RGC) has through The Ministry of Rural Development (MRD) received a grant from the Nordic Development Fund (NDF) and ADB Strategic Climate Fund (SCF) toward the cost of the Rural Roads Improvement Project (RRIP II), and intends to apply part of the Loan and Grant to payments under the Contract No. RRIP II/MRD-CW9A for the Green Plating along 303.9 km in Tboung Khmum, Takeo and Kampong Speu provinces, the Contract No. RRIP II/MRD-CW10A for the Green Plating along 258.8 km in Kampong Chhnang, Pursat and Battambang provinces, and the Contract No. RRIP II/MRD-CW11A for the Green Plating along 177.2 km in Banteay Meanchey, Siem Reap and Kampong Thom provinces. Bidding is open to bidders who can prove their eligibility and qualification as mentioned hereunder and in the Bidding Documents.

2. The Project Implementation Unit of MRD now invites sealed bids from eligible and qualified bidders for the Packages mentioned above. The contract period is 24 months from the Start Date.
3. Procurement will be conducted through National Competitive Bidding Procedures outlined in the Procurement Manual for Externally Financed Projects/Programs, and under the laws and regulations governing public procurement within the Kingdom of Cambodia.
4. This invitation is open to bidders from all eligible countries as described in the Bidding Documents.
5. Interested eligible bidders may obtain further information from and inspect the Bidding Documents at the address given below for 15 days between 8:00 am - 11:30 am and 2:30 pm - 5:00 pm on all working days from **27 November 2017 to 11 December 2017**.
6. Prospective bidders' attention is drawn to the Instruction to Bidders in the bidding documents and the qualification requirements outlined in ITB/Bid Data Sheet Clause 6.3 and 6.1.

10. Bids shall be accompanied by a Bid Security in the amount of **USD 4,000**

The RGC and the Ministry of Rural Development will respectively declare a firm ineligible either indefinitely or for a stated period of time, to be awarded a contract funded by the RGC and/or Ministry of Rural Development, if they at any time determines that the firm has engaged in corrupt or fraudulent, coercive, collusive or obstructive practices in completing or in executing a contract.
