1. The Kingdom of Cambodia has applied financing from the Asian Development Bank (ADB) towards the cost of **Rural Roads Improvement III**. Part of the financing will be used for payments under the contract named above.
2. **The Project Management Unit**, Ministry of Rural Development (MRD) invites sealed bids from eligible bidders for the Improvement of 2 Roads 23.7 Km in Tboung Khmum Province (IFB No. 2018-RRIP III-OCB-01. The Construction period is Twenty-Four (24) Months.
3. **Open Competitive Bidding (OCB)** will be conducted in accordance with ADB's Procurement Policy (2017, as amended from time to time) and ADS's Procurement Regulations for A DB Borrowers (2017, as amended from time to time) and is open to all eligible Bidders as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - The minimum average annual volume of construction work of the successful Bidder over the last 3 years (2015, 2016 & 2017) shall be **USD 4.1 Million**
 - The bidder shall have satisfactorily completed at least one contracts similar in size and nature as prime contractor or sub-contractor in the last five (5) years (to comply with this requirement, works cited should be at least 70% complete, billed and paid) with contractual value each of the contract of not less than **USD 2.18 Million**.
 - The minimum amount of liquid assets and/or credit facilities net of other contractual commitments of the successful Bidder shall be: **US\$0.34 Million**
 - Bidders must demonstrate that they have available the minimum qualified one construction manager and one material engineer.
