A Pre-Bid Meeting will be held on 24th of May 2024 at 3:00 PM (ICT) at Ministry of Rural Development (MRD), 3rd floor, Room No. 305, #771-773 Monivong Blvd., Sangkat Boeng Trobaek, Khan Chomkarmon, Phnom Penh to ensure that all potential bidders understand the bidding procedure and World Bank Environmental and Social Safeguard (ESS) requirements and the need to include Environmental, Social, Health and Safety (ESHS) management related cost items in the BOQ.

This Batch is constituted by 2 Lots. In accordance with 3. Evaluation of Bids, 3.3 Multiple Contracts under Section III. Qualification and Evaluation Criteria, the Bidders have the option to bid for any one or more lots. Bids will be evaluated lot-wise, taking into account discounts offered, if any, for combined lots.

Qualification Documents and Bids must be delivered to the address indicated in the clause ITB 22.1 of the bidding documents on or before 9:00 AM (ICT), 17th of June 2024. Late Qualification Documents and Bids will be rejected.

In the first public session, only the Qualification Documents will be opened in the presence of the Bidders' designated representatives. In the second public session only the Bids of those Bidders who have fulfilled the qualification criteria will be opened.

There shall not be financial data under any circumstances in the 1st Envelope - Qualification Document, other than those required and defined in Section III. Qualification and Evaluation Criteria, 1. Evaluation of Eligibility and Qualification and in Section IV. Qualification and Bidding Forms, 1st Envelope - Qualification Document (Qualification Forms).

All Bids must be accompanied by a Bid Security.
