**Project measures**: The objective of the second phase of the Rural Infrastructure Development Programme for Cambodia – Phase 2" (RID4CAM-2) project (the "Project") is to improve the socio-economic living conditions of the poor and vulnerable population in rural areas and improve their climate resilience through enhancing the sustainability of the Cambodian road network.
